### Alabama

#### Department of Corrections

This database contains felony information on individuals that are or have been under the jurisdiction of the Alabama Department of Corrections. This data dates back to February 2004. County of commitment and release date only are reported. This jurisdiction is included in the national search only. This data is updated monthly.

#### Non-Instant Statewide Available

The Alabama Administrative Office of the Courts (AOC) provides statewide court data back to 1994 (earlier records may exist). Records are verified by name and date of birth. Record information includes felony and misdemeanor offenses - identified separately. Offense description, county of conviction, file date, conviction date, case number and disposition are reported. This search has a same day turn around.

#### P.O.D. (Proprietary Offender Data)

This database is comprised of proprietary criminal data compiled from previously ordered county, statewide and federal criminal requests, from all 50 states, which contained records, as well as data contributed by the JDP Solution Provider Network.

#### Sex Offender Registry

The sex offender registry is maintained by the Alabama Department of Public Safety, Bureau of Investigation. This registry includes individuals convicted of sex offense(s) on or after 09/01/1999. Convicted multiple offenders prior to 09/01/1999 are also required to register. Registry information includes offender name, date of birth, address of registration, offender ID number, description of sex offense, eye color, height, weight, race and gender. Photo of registered sex offender provided as made available by the data source.

### Alaska

#### Department of Corrections

This database contains a snapshot of those offenders incarcerated since April 2008 by the Colorado Department of Corrections. This data contains name, DOB, commitment location, and DOC number; however no offense description is supplied. This jurisdiction is included in the national search only. This data is updated monthly.

#### Non-Instant Statewide Available

The Colorado Administrative Office of the Courts (AOC) provides statewide court data back to 1995 (earlier records exist from individual counties). Records are verified by name and date of birth. Record information includes felony and misdemeanor offenses with the exception of the Denver General Sessions Court (misdemeanors) which is not included. Offense description, county of conviction, file date, conviction date, criminal statute number, case number, ticket number, fines, sentence length, probation and disposition are reported. This search has a 90 minute turn around.

#### P.O.D. (Proprietary Offender Data)

This database is comprised of proprietary criminal data compiled from previously ordered county, statewide and federal criminal requests, from all 50 states, which contained records, as well as data contributed by the JDP Solution Provider Network.

#### Sex Offender Registry

The sex offender registry is maintained by the Colorado Bureau of Investigation (CBI). This registry includes convicted high risk sexually violent predators, multiple sex offenders and county sex offender registrants as provided to CBI. Registry information includes offender name, alias name, sex offense description, date of birth and address of registration. Photo of registered sex offender provided as made available by the data source.

This database contains historical felony and misdemeanor information on individuals that have been incarcerated in a Connecticut correctional institution, paroled or under community supervision of the Connecticut Department of Corrections prior to December of 2003.

#### Department of Corrections

This database began its compilation of information when the Department of Corrections changed its reporting format in December of 2003. All information prior to December of 2003 is contained in the Archived Corrections database. This database contains current and historical felony and misdemeanor information on individuals that are or have been incarcerated under the jurisdiction of the Connecticut Department of Corrections. This data is updated monthly. NOTE: per the jurisdiction: It is extremely important to note that a person's current incarceration does not necessarily indicate they have been convicted of a crime, as Connecticut's correctional system also holds those who are awaiting trial.

#### Administrative Office of the Courts

This database contains current and historical felony, misdemeanor, traffic, infraction, and violation information on individuals who are or have been under the jurisdiction of the Connecticut Court system. Only cases in which at least one charge was a conviction are included. These records date back at least seven years. This data is updated monthly.

#### Sex Offender Registry

Offenders who were released into the community prior to October 1, 1988 are not required to register. Photo of registered sex offender provided as made available by the data source. Offense description, file date, disposition and disposition date, date of arrest and sentence information are reported. Expected turnaround is 1-2 business days.

#### P.O.D. (Proprietary Offender Data)

This database is comprised of proprietary criminal data compiled from previously ordered county, statewide and federal criminal requests, from all 50 states, which contained records, as well as data contributed by the JDP Solution Provider Network.

#### Sex Offender Registry

The sex offender registry is maintained by the Delaware State Police and Bureau of Investigation. This registry includes individuals who have been convicted of sex offense(s) on or after 06/24/1994. Registry information includes offender name, alias name, sex offense description, date of conviction, state ID number, date of birth, address of registration, race, eye color, skin tone, height and weight. Offenders who were released into the community prior to June 24, 1994 are not required to register. Photo of registered sex offender provided as made available by the data source.

### District of Columbia

#### Department of Corrections

The Washington, D.C. Department of Corrections provides records on persons who passed through the District prison system between 1987-2002. Records are verified by name and date of birth. Record information includes felony and state-level misdemeanors-- identified separately. This jurisdiction is included in the national search only.

#### Non-Instant Statewide Available

The District of Columbia District Court Administrator (AOC) provides district wide court data back to 1979. Records are verified by name and date of birth. Record information includes felony and misdemeanor offenses ? identified separately. Offense description, county of conviction, file date, conviction date, case number, and disposition are reported. Many requests are returned within 90 minutes, with the remainder returned in one business day.
